

RESOLUTION 5:4 - #SC 1 of 2022

WHEREAS, the Town Board has received a recommendation from the Director of Development that local law amendments be made to Chapter 210, entitled “Zoning”, to allow outdoor music in certain Zoning Districts, and that a new Chapter 145 to be known as “Outdoor Music” be added, and

WHEREAS, the proposed amendments are annexed hereto as Exhibit A and incorporated herein as if recited verbatim, with the words underlined to be added, and those words ~~stricken~~ to be deleted, and the Town Board does direct that said amendments be spread across the record as if they, in fact, had been read verbatim; and

WHEREAS, this action to amend the Zoning Law is an Unlisted Action under the New York State Environmental Quality Review Act, and an Environmental Assessment Form (EAF) is annexed hereto; and

WHEREAS, the Town Board has determined that the proposed amendment must be referred to the Dutchess County Department of Planning and Economic Development and to the Town Planning Board for review and recommendation; and

WHEREAS, the amendment requires a public hearing.

NOW, THEREFORE BE IT RESOLVED THAT:

1. The Town Board hereby states that because only the Town Board can consider and adopt changes to the Town Code that it is the only involved agency, and the Board hereby declares that it will conduct the environmental review of this action pursuant to Article 8 of the Environmental Conservation Law; and
2. The Town Board hereby sets a public hearing on the proposed amendments for June 1, 2022, at 7:00 PM, or as soon thereafter as the matter may come to be heard, in the Town Hall, One Overocker Road, Poughkeepsie, New York, the notice of which hearing shall advise that changes to this law may be made regarding distance from source and/or amplifications prior to adoption; and

3. The Town Board refers this matter to the Dutchess County Department of Planning and Economic Development for a recommendation pursuant to GML 239-m; and
4. The Town Board refers this matter to the Planning Board for an advisory report pursuant to Town Code Sections 210-154; and
5. The Town Board directs the Town Clerk to notify the Town Clerks of each of the surrounding municipalities of the public hearing pursuant to GML 239-nn.

**TOWN OF POUGHKEEPSIE
LOCAL LAW NO. __ (PROPOSED) OF THE YEAR 2022**

**A LOCAL LAW TO AMEND THE CODE OF THE TOWN OF POUGHKEEPSIE TO
ESTABLISH A NEW CHAPTER 145 TO BE KNOWN AS “OUTDOOR MUSIC,” AND
TO AMEND CHAPTER 210 ENTITLED “ZONING” TO ALLOW OUTDOOR MUSIC IN
CERTAIN ZONING DISTRICTS IN THE TOWN**

BE IT ENACTED by the Town Board of the Town of Poughkeepsie as follows:

SECTION 1. LEGISLATIVE INTENT

This Local Law amends the Code of the Town of Poughkeepsie to establish a new Chapter 145 to be known as “Outdoor Music,” and to amend Chapter 210 entitled “Zoning,” to allow outdoor music on a regular basis as an accessory use to an approved outdoor restaurant dining facility in the Highway Business and Arlington Town Center Zoning Districts subject to certain conditions and approvals. By limiting the location and type of outdoor music, and by requiring that outdoor music undergo review and receive approval from the Town Board, this Local Law reduces the potential adverse impacts associated with outdoor music, particularly on adjoining residential neighborhoods, and will protect the health, safety, and welfare of Town residents. The proposed amendment is consistent with the recommendations of the Town's 2021 *Comprehensive Plan* and with “Greenway Connections: Greenway Compact Program and Guides for Dutchess County Communities” pursuant to Chapter 18 of the Town Code.

SECTION 2. APPLICATION

This Local Law shall apply within the Highway Business (B-H) and Arlington Town Center (ATC) Zoning Districts in the Town of Poughkeepsie.

SECTION 3. SEVERABILITY

The invalidity of any word, section, clause, paragraph, sentence, part, or provision of this Local Law shall not affect the validity of any other part of this Local Law, which can be given effect without such part or parts.

SECTION 4. ADOPTION OF A NEW CHAPTER 145 ENTITLED "OUTDOOR MUSIC"

§ 4.1. A new Chapter 145 is hereby inserted into the Code of the Town of Poughkeepsie to read as follows:

CHAPTER 145. OUTDOOR MUSIC

§ 145-1. Purpose. It is the intent of this Chapter to allow for outdoor music on a regular basis in certain zoning districts in a manner that reduces the potential adverse impacts associated with outdoor music, particularly on adjoining residential neighborhoods, and will protect the health, safety, and welfare of Town residents. This Chapter describes procedures for obtaining a permit for outdoor music, and is intended to operate in conjunction with the regulations of the Town of Poughkeepsie Code Chapter 210 entitled "Zoning."

§ 145-2. Applicability. This Chapter is intended to apply to Restaurants and other businesses having outdoor dining facilities (Cumulatively "Restaurant"). Subject to the conditions set forth in this Chapter, outdoor music shall be permitted only as accessory to an outdoor restaurant dining facility which has been approved pursuant to §§ 210-102 or 210-109.1 of the Town Code in the Highway Business (B-H) and Arlington Town Center (ATC) Zoning Districts. This Chapter shall not apply to events for which an event permit has been issued by the Town.

§ 145-3. Outdoor music permit required. It shall be unlawful for any Restaurant having an outdoor dining facility to allow outdoor music of any kind, including live performances, the use of any sound-producing, sound-reproducing, or sound-amplifying device outdoors, or sound amplified from the interior of the principal structure or building that can be heard outdoors, without first having obtained an outdoor music permit for such purpose from the Town Board in accordance with the provisions of this Chapter.

§ 145-4. Term of Permit. An outdoor music permit shall be valid for one year from the date of issuance, unless sooner terminated or revoked. All applications for a renewal of a permit shall be filed 45 days before the expiration of the current permit.

§ 145-5. Application for permit.

A. Any restaurant seeking permission for outdoor music shall make a written application for an outdoor music permit to the Town Clerk, who shall promptly refer the application to the Zoning Administrator for review and comment, which shall be provided within 14 days of receipt of a complete application, and thereafter if complete placed on a Town Board agenda. Applications for outdoor music permits shall be on forms provided by the Town of Poughkeepsie, and shall include the information required by this Chapter, including the following:

- (1) A written statement describing the type, frequency, and source of the proposed outdoor music.
- (2) Name, signature, telephone number, and e-mail address of the applicant, and of the owner of record, if different. If the applicant is not the owner of record, a letter of authorization from the owner shall be required.
- (3) Address of the property and Tax Parcel ID number where the outdoor music is proposed.

- (4) Zoning classification(s) of the property.
- (5) Approved site plan for the outdoor restaurant dining facility, sufficient to show the measurements between the facility and all property boundaries.
- (6) Payment of a non-refundable application fee in accordance with the fee schedule established and periodically reviewed by the Town Board. In no instance shall the filing of an application and payment of an application fee be construed as permission to operate outdoor music.
- (7) Consent to enter the premises to monitor noise.
- (8) Such other information and/or documentation deemed necessary by the Zoning Administrator or other enforcement officer of the Town.

B. Upon issuance of the permit, the applicant shall sign a copy of the permit, which copy shall be maintained in the Town file, to indicate the applicant's knowledge of any conditions imposed.

§ 145-6. **Permit Fee.** A non-refundable permit fee shall be payable upon issuance of the outdoor music permit in accordance with the fee schedule established and periodically reviewed by resolution of the Town Board.

§ 145-7. **Conditions and restrictions of permit.** All permits issued pursuant to this Chapter shall be subject to the following conditions and restrictions, whether or not they are itemized on the permit:

- A. In the ATC District, only acoustic outdoor music shall be permitted. The placement, installation, and use of any sound-producing, sound-reproducing, or sound-amplifying device outdoors shall be prohibited, and no sound amplified from the interior of the principal structure or building that can be heard outdoors shall be permitted.
- B. In the B-H District, outdoor music, whether acoustic or amplified, and sound amplified from the interior of the principal structure or building shall be permitted until 10:00 p.m., provided that such music or sound does not exceed 60 dBA measured at a distance of 100 feet from the source of the noise, unless the property boundary is less than 50 feet from the source of the noise, in which case it shall be measured at the property boundary. All measurements shall be made on the A-weighted sound level of a sound level meter with a slow response. This shall supersede the provisions of § 139-5C of the Town Code.

§ 145-8. **Enforcement**

- A. It shall be the duty of the Town of Poughkeepsie Police Department, the Building Inspector, the Zoning Administrator, and their duly authorized representatives to enforce the provisions of this Chapter.
- B. Appearance tickets. The individuals identified in Subsection A are authorized to issue appearance tickets as defined in § 150.10 of the Criminal Procedure Law, as well as orders to remedy and notices of violation, to enforce the provisions of this Chapter.

§ 145–9. Penalties for Offenses

A. Fines.

- (1) The first violation of this Chapter shall be punished by a fine of up to \$1,000.
- (2) The second violation of this Chapter, within 12 months after the first violation, shall be punished by a fine of not less than \$1,000 and up to \$1,500.
- (3) Further violations within 12 months after the last violation shall be punished by a fine of not less than \$1,500 and up to \$2,500.

B. Each such act which either continues or is repeated more than 1/2 hour after issuance of written notice of violation of this Chapter shall be a separate offense and shall be prosecuted as a separate offense.

C. If the violation occurs on the premises of rental property which is occupied by someone other than the owner, then the owner must also be notified in writing that the violation has occurred, within five business days of said violation, except that failure to provide such notice shall not affect the prosecution of the person or persons charged with said violation.

D. In addition to any other remedies set forth herein authorizing the Town to enforce the provisions of this Chapter, establishing penalties, and setting forth additional remedies, a person charged with the responsibility to enforce the provisions of this Chapter may impose a civil fine or agree to a civil fine not to exceed \$1,000 per day for each day of the violation. If said civil fine is imposed, then the alleged violator may appeal to the Town Board of the Town of Poughkeepsie.

§ 145–10. Revocation of Permit

A. The Town may suspend or revoke a permit issued pursuant to this Chapter by order if it finds that the applicant or permittee has not complied with any or all of the terms of such permit, has exceeded the authority granted in the permit or has failed to conduct the music in the manner set forth in the approved application.

B. The Town shall set forth, in writing, in the file it keeps regarding a permit application, its findings and reasons for revoking or suspending a permit pursuant to this section and provide a copy of the same to the permittee, and the owner, if different.

C. Such revocation or suspension shall be in effect until lifted by the Director of Municipal Development after review.

SECTION 5. AMENDMENTS TO ARTICLE VIII OF THE ZONING LAW ENTITLED "SUPPLEMENTARY REGULATIONS"

§ 5.1. Subsections 210-102B(8) and (9) of the Code are hereby amended by deleting them in their entirety and replacing them with the following new §§ 210-102B(8) and (9):

- (8) Unless otherwise permitted by Chapter 145 of the Town Code, outdoor music, live performances, or sound amplified from the interior of the principal structure or building shall be prohibited, except in the HRDD where it is permitted until 10:00 p.m., provided that such music or sound is produced from a source that is no less than 150 feet from the nearest residential use in the HRDD, and does not exceed 60 dBA as measured at a distance of 50 feet from the source of the noise. All measurements shall be made on the A-weighted sound level of a sound level meter with a slow response.
- (9) Unless otherwise permitted by Chapter 145 of the Town Code, the placement, installation, and use of sound amplifiers or public address systems shall be prohibited, except in the HRDD where it is permitted until 10:00 p.m., provided that such music or sound is produced from a source that is no less than 150 feet from the nearest residential use in the HRDD, and does not exceed 60 dBA as measured at a distance of 50 feet from the source of the noise. All measurements shall be made on the A-weighted sound level of a sound level meter with a slow response.

SECTION 6. EFFECTIVE DATE

This local law shall take effect immediately after it is filed with the Secretary of State as provided in section twenty-seven of the Municipal Home Rule Law.
