WHEREAS, the Town Board finds that it is in the best interest of the Town of Poughkeepsie to amend the Town Code, Chapter 210, “Zoning”, specifically 210-61, to revise the setback provisions for cannabis retail dispensaries; now therefore

BE IT RESOLVED, that the Town Board of the Town of Poughkeepsie does hereby set the 22nd day of October, 2025 at 7:00 p.m. at the Town Hall, Town of Poughkeepsie, One Overocker Road, Poughkeepsie, NY, as the time, date and place of a public hearing at which all parties in interest and citizens may be heard as to whether or not the Town Board of the Town of Poughkeepsie should adopt the proposed Local Law to Amend Chapter 210, of the Town Code entitled “Zoning”, specifically 210-61, regarding Cannabis Retail Dispensaries (the “Local Law”) annexed hereto; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Poughkeepsie does hereby waive the verbatim reading of said proposed Local Law and does hereby direct the Town Clerk to spread the proposed Local Law across the record as if it had been read aloud; and

BE IT FURTHER RESOLVED, that pursuant to the provisions of SEQRA, the Town Board determines that the adoption of the proposed Local Law is a Type I action (see, 6 NYCRR 617.4[b][2]), and determines that the Town Board is the only involved agency, and therefore designates itself lead agency for the environmental review of the proposed Local Law; and

BE IT FURTHER RESOLVED, that the Town Board accepts the attached Full Environmental Assessment Form  Part 1 to commence the SEQRA process; and

BE IT FURTHER RESOLVED, that the Town Clerk is hereby directed to post a Notice of Public Hearing in the Town's official newspaper, the Poughkeepsie Journal, and on the bulletin board maintained by the Town Clerk in the Town Hall not less than ten (10) days prior to said public hearing; and

BE IT FURTHER RESOLVED, to refer a copy of this resolution, the annexed proposed Local Law, and the Notice of Public Hearing to the municipal clerk of each abutting municipality not less than ten (10) days prior to the public hearing and to refer a copy of this resolution, the annexed proposed local law, and the Notice of Public Hearing to the Dutchess County Department of Planning and Economic Development for advisory review in accordance with §239-m of the General Municipal Law, and to distribute a copy of this resolution, the annexed proposed local law and the Notice of Public Hearing to the Town of Poughkeepsie Planning Board for its review and recommendation pursuant to Town Code §210-154.

TOWN OF POUGHKEEPSIE

LOCAL LAW NO. __ (PROPOSED) OF THE YEAR 2025

A LOCAL LAW TO AMEND CHAPTER 210 OF THE CODE OF THE TOWN OF POUGHKEEPSIE ENTITLED “ZONING” TO REVISE THE SETBACK PROVISIONS FOR CANNABIS RETAIL DISPENSARIES

BE IT ENACTED by the Town Board of the Town of Poughkeepsie as follows:

SECTION 1. LEGISLATIVE INTENT

This local law amends the Town of Poughkeepsie Zoning Law to revise the setback provisions for cannabis retail dispensaries. The purpose is to regulate the location of cannabis retail dispensaries in the interest of the public health, safety, and general welfare, while ensuring that a reasonable number of sites remain available for this use within the Town. The proposed regulations are consistent with *Greenway Connections: Greenway Compact Program and Guides for Dutchess County Communities* pursuant to Chapter 18 of the Town Code, and with the recommendations of the Town’s 2021 *Comprehensive Plan*.

SECTION 2. APPLICATION

This local law shall apply within the Arlington Town Center (ATC) District, Highway Business (B-H) District, Heavy Industrial (I-H) District, Light Industrial (I-L) District, and Neighborhood Highway Business (B-NH) District in the Town of Poughkeepsie.

SECTION 3. SEVERABILITY

The invalidity of any word, section, clause, paragraph, sentence, part, or provision of this Local Law shall not affect the validity of any other part of this Local Law which can be given effect without such part or parts.

SECTION 4. AMENDMENTS TO ARTICLE VIII OF THE ZONING LAW ENTITLED ‘SUPPLEMENTARY REGULATIONS’

§ 4.1. The existing § 210-61E(2) is hereby deleted in its entirety and replaced with the following new § 210-61E(2):

- (2) Context Map. A map identifying the location of the proposed establishment and the locations of all nearby places of religious worship, schools, child day-care centers, school-age child day-care facilities, small day-care centers, nursery schools, public youth facilities, and existing cannabis retail dispensaries. The map shall include measured distances

sufficient to demonstrate that the proposed establishment complies with the standards of Subsection G below.

§ 4.2. The existing § 210-61G is hereby deleted in its entirety and replaced with the following new § 210-61G:

G. Buffer zones. No cannabis retail dispensary shall be located within the following buffer zones; provided, however, that if any applicable statute or regulation requires a greater distance, the greater distance shall control:

- (1) Within 200 feet of a property occupied as a place of religious worship;
- (2) Within 500 feet of a property occupied as a school serving children in any grade or grades from kindergarten through grade 12;
- (3) Within 500 feet of a property occupied as a child day-care center, a school-age child day-care facility, a small day-care center, or nursery school;
- (4) Within 500 feet of a property occupied as a public youth facility, including but not limited to a Town or County park with active recreational amenities such as playgrounds or ballfields; or
- (5) Within 500 feet of a property occupied as an existing cannabis retail dispensary.
- (6) Distances required by this subsection shall be measured in a straight line from the nearest property line of each facility referenced in subsections (1) to (5) to the nearest property line of the lot to be occupied by the proposed cannabis retail dispensary, regardless of whether the facility referenced in subsections (1) to (5) is located within the Town.

SECTION 5. EFFECTIVE DATE

This local law shall take effect immediately after it is filed with the Secretary of State as provided in section twenty-seven of the Municipal Home Rule Law.
